







#### **■** EBITDA / EBITDA Margin




#### ■ Operating Income / Operating Income on Net Sales



### ■ Return on Total Assets (ROA) / Return on Equity (ROE)




#### ■ Overseas Sales / Overseas Sales Ratio








### ■ Current Ratio


### **■** Turnover of Total Assets




#### ■ Turnover of Net Assets










### ■ Cash Flow Margin











### ■ Price / Book Value Ratio (PBR)




